In person small groups after-school for 5th grade starting next week specifically for socio-emotional learning.

Teachers are sharing their preferences with Mimi and based on that they will be matched up with Student/Parent preference.

AM/PM will be similar to Kindergarten AM/PM and parent's will be given a choice. Specialty classes (band students) may be put as PM students on campus.

For those who choose to stay remote, the schedule will be very similar to how it is now. but, does not guarantee that it will be the same teacher.

Specialists teachers stay remote (music, PE, science).

Fallback plan - Planning to move forward until it gets shut-down. After the schedule changes, students remain with their new teacher.
