# 1. 3:00 pm Call to Order

a. Allie joined the School Site Council as a new member, and was welcomed by everyone.

## 3. 3:10 pm Approval of minutes from Oct Blaire Wyatt

a. Blaire made a motion to approve minutes from Oct. Lauren seconded the motion, and all in favor approved the minutes as presented.

#### 5. 3:15 pm SARC Report

Mimi Quan

- a. Mimi explained the SARC report in detail, which is a report card for last year, available for all public schools on their websites. Current year's report is not yet filled in.
- b. SARC related questions were raised:
  - i. Blair asked if FastBridge was needed to fill the local assessment (page 12), to which Mimi responded: yes, but it is at the district level.
  - ii. Mike asked school facility's rating (page 2) and why were some rated as Fair. Mimi replied she doesn't know as she doesn't get to rate.
  - iii. Blair asked if they have different a code for Chronic Absenteeism due to COVID quarantine next year. Mimi didn't know.
  - iv. Mike asked about Elementary Average Class Size and Class Size Distribution (page 18). Mimi replied that it fluctuates, and this data is populated by VTS with data provided by CVE.
  - v. Ellie mentioned if the Class Size would depend on virtual to in person class for second semester. Mimi's response was that it depends on enrollments, and if the home site school has room, they can be accommodated in person, but there are no guarantees.
  - vi. Mike asked about funding expenditure, why 28% lower is spent than average. Mimi replied that it is basically a funding formula depending on the need of the students. Title I schools (schools with more low income families) get more funding than QR.

- vii. Mike asked where do the funds go. Mimi explained that they go towards staffing. Jigar added that Learning Fund tries to bridge the gap for QR. He further added that LF puts together a pie chart that shows data by needs (high, medium and low).
- viii. Mike asked if other districts are spending more per student or they have fewer students per teacher; Jigar replied it is more money for students.
- ix. Mike's next question was on how do schools that get extra funds spend it, to which there wasn't an answer. An additional point was made that the report has a mix of elementary and middle schools, which is making the data incomparable between districts. There was a discussion on whether Quail Run is a high needs school, but not in a high needs district.
- x. Blaire asked about restricted and unrestricted expenditures. Mimi explained restricted is for certain programs, like those tied to curriculum, or in Title I schools, for students in need or for professional development. Unrestricted is at the school's discretion.
- xi. Jigar asked for the motion to be approved with the SARC as it is filled in by Mimi, and see the full report when it is available. Everyone agrees. Motion passes.
